Ms. Haynes will be paid an annual salary of \$24,336 beginning September 13, 2018.

5. Head Track/Cross Country Coach

It was the president's recommendation that the Board approve the employment of Noe Hernandez as Head Track/Cross Country Coach. Mr. Hernandez has a Bachelors of Science in Physical Education from Lindenwood University.

Mr. Hernandez's prior work experience includes Paraprofessional PE Aide at Mission CISD, Assistant Summer Track Coach at City of Mission Parks and Recreation and Head Summer Track Coach at City of La Joya Youth Center.

Mr. Hernandez will be paid an annual salary of \$35,313 (I + 4) beginning September 24, 2018.

VIII. NEW BUSINESS

A. Purchase Policy - First Reading

The current purchasing policy was written long before the proliferation of credit cards and the need for more immediate buying. The current policy requires full requisition approval before anything can be purchased. When paying by credit card, as we are required to do in many instances such as airline tickets, this can be problematic. If prices change from the time the requisition is approved, then the credit card is used, the business office must revisit the requisition to update the prices, causing double the amount of work and an opportunity to make a mistake in the update. As it stands now employees receive less formal approval from their supervisor, such as an email or text message, then use the cards for the purchase. After the purchase is made they complete the requisition and it is formally approved so that it has the final correct amount. This current practice, while much more efficient and allows for proper oversight, is a violation of policy.

Administration sought input from the college's auditing firm for this update. Additionally it was discussed at length by the Executive Committee and approved at a recent meeting. The following is a proposed change to the Purchase Policy, changes are in yellow.

Purchases – Unapproved becomes a part of the Purchasing – General Policies

Unless otherwise denoted in policy, all purchases must be preapproved. Generally, a purchase requisition must be approved before any goods/services can be contracted or purchased on behalf of NCCC. If the purchasing policy is violated and goods/services are contracted or purchased, the employee may be required to consider these goods/services as their personal property and also be required to reimburse the College for the full cost.

In the case of college credit card purchases or purchases made on account, every effort should be made to acquire pre-approval from the employee's supervisor before the transaction is made. An approved pre-travel request is considered preauthorization for travel related credit card purchases made while traveling. A requisition must be completed within three business days or as soon as practicable after the credit card transaction is complete. Failure to receive pre-approval, return the purchase receipt, or complete the purchase process in a timely fashion could result in corrective action for the employee including loss of credit card, reimbursement to the college for the purchase, and/or additional discipline measures taken against the employee. The bid and expense policy applies in all purchases, including credit card purchases.

This is a first reading only, no action took place.



I. **Projects Update** (submitted by Kyle Seufert, Kerry Ranabargar and Ben Smith)

A. Energy performance contract

- a. All of the mechanical work is complete but has not been without issues.
- b. We are still working on control issues.
 - i. Installed new controls in the CLC/CAVE which appear to be operating correctly.
 - ii. We will then install in other three original campus buildings.
 - iii. Remaining programming such as scheduling still needs to be completed.
- c. We are still holding the retainage payment and performance bond.
- d. NCCC still has to install fencing around the condensing units and transformer/switch gear.

B. Stoltz Hall Classroom Renovation (pics below)

- a. New classroom technology PC, HD projector, Smart Board, and sound system.
- b. New lecterns.
- c. New ceiling tiles, grid, lighting options.
- d. Removed old unit ventilators and piping, repaired ventilation holes; new paint and carpet.
- e. Lecture Hall received makeover new projector, removed old TV's, front shelves, and new paint up front.









C. Student Union Walk-in Fridge/Freezer (pics below)

- a. Old freezer size is 6'W x 8'L x 8'H...roughly 48 sq ft or 384 cu ft, while new space is 12'W x 12'L x 10'H, which is roughly 144 sq ft or 1440 cu ft. Therefore, the new freezer has roughly 300% more floor space and 375% more cubic space.
- b. Old fridge size is 8'W x 9'L x 8'H...roughly 72 sq ft or 576 cu ft, while new space is 12'W x 25'L x 10'H, which is roughly 300 sq ft or 3000 cu ft. Therefore, the new fridge has roughly 415% more floor space and 520% more cubic space.









D. Lafayette House (pics below)

- a. Renovated kitchen.
- b. Entire house protected with fire sprinkler system.
- c. Installed monitored safety systems.
- d. Installed security cameras throughout shared spaces.




II. Safety/Security (submitted by Kerry Ranabargar and Ben Smith)

A. Title IX

- a. Our Title IX Team including the three deputy coordinators, Dr. Robb as Coordinator, and seven others continue our on-going training requirements under OCR guidelines.
- b. Dr. Robb has taken over Title IX training responsibilities as TIXC.
- c. As a reminder, the college has implemented the Maxient software platform, a cloud-based, student discipline and Title IX issue reporting system and that process continues to go well.
- d. This will be my last TIXC report.

B. New Initiatives/Training/Testing

a. NIMAA (National Intercollegiate Mutual Aid Agreement) As you know, the board approved the NIMAA in May of last year making NCCC only the second community college in the country as well as the only IHE (institution of higher education) anywhere in the middle of the country to be a part of the agreement. Since then, Pratt Community College and Missouri State University have also ratified the agreement. Other Kansas IHE's are still showing interest. Below is a map of current members as of July, 2018:



b. We converted our online daily crime log over from the one we built in house to a new one which is driven from Maxient (Student Conduct System) reports. Once a case is created in Maxient, the daily crime log automatically populates as appropriate. This saves labor time to re-input

- incidents plus it assures that we are in compliance with the Clery requirement regarding posting an incident within two business days of it being reported.
- c. We have installed six cameras in the new parking structure and will be installing twenty at the Ross Lane facility. We also installed security cameras, access control and fire monitoring at the Lafayette house.
- d. We trained the Safety Officers on the access control system so that they can access and monitor it from the SO office in Bideau Hall. In the past this has been handled by Technology Services remotely after hours so this will be a big help to those here on campus during the evening should issues arise.
- e. Kerry and I will be attending the National Seminar and Tabletop Exercise for Institutions of Higher Education (NTTX) sponsored by the Department of Homeland Security in San Antonio month. This series brings together senior higher education leaders, as well as federal, state and local representatives from departments and agencies that support campus resilience to participate in workshops and work through a designed emergency scenario. This year's event will focus on *threats of campus disorder during a large event*.
- f. Kerry and I will also be attending the Regional Tabletop Exercise for Institutions of Higher Education (RTTX) sponsored by the Department of Homeland Security at UCO in Edmond, OK in October. This one-day event will include a tabletop exercise and an after-action review session on preparing participants to respond to a campus emergency involving *a tornado during a large campus event*.
- g. We have not had a good participation rate or usage response with the LiveSafe mobile app this past year and will be discontinuing that service contract this coming February, 2019.
- h. We continue to use the internationally-based Vaisala automated lightning detection system. The automated system notifies ten NCCC employees using email cautions and text warnings when lightning is within 40 miles, 20 miles and 8 miles as well as sending us All-Clear messages.
- i. We continue to add emergency door stop holders to all classrooms and most offices as time and schedules permit on both campuses.
- j. Kerry and I and the residential life staff including RA's received training a month ago on drug recognition from the Chanute Police Department.
- k. We have completed and continue to test our emergency alert systems and added additional beacon speakers in various locations based upon our previous emergency alert testing feedback.
- 1. We also continue to update the EAP as statutes and regulations require. We will bring the full EAP to the board for approval after the Safety and Security Committee has reviewed it and the Executive Committee has approved it, usually at the March or April board meeting.


C. On-Going Safety Measures

- a. Completed monthly safety walk-throughs with VPO and Director of Facilities and created appropriate work orders for corrective actions.
- b. All weekly and monthly inspections have been completed and documented.
- c. The semi-annual hood, boiler and chiller inspections and preventative maintenance operations (PMs) are completed.
- d. All staff completed ongoing training with staff stressing safety and standardized procedures.
- e. All training received additional staff training on Emergency Action Plan (EAP) guidelines.

III. Technology Services (submitted by Kerry Ranabargar)


A. Information Technology & Information Security

- a. Completed Projects
 - i. Vulnerability Scanner We implemented a highly recommended vulnerability scanning application to bolster our security posture both internally and externally. Vulnerability scanners do a number of things including scan for missing operating system patches and for Personally Identifiable information (PII) within files. They provide actionable reporting so that we can stay ahead of any security issues that we may not know about due to the sheer size of our network and number of devices we manage. A sample dashboard can be seen below.



ii. **Independent Risk Assessment** – AOS (now Converge One) performed a security assessment of our computing environment to identify potential vulnerabilities. This consisted of a combination of interviews, vulnerability assessment scans, and physical inspection. Key issues that were identified include patch management, perimeter hardening and SSL implementation. Recommendations for remediation include perimeter hardening, patch management, and reconfiguration. We have already addressed most of their recommended remediation's and are still evaluating products and services to address each of these items that remain.

iii. Internal Risk Assessment – Updated the current internal assessment of risk as it pertains to cyber security and controls. The methodology used was recommended by the Federal Student Aid (FSA) office and is the same one utilized by the Federal Financial Institutions Examination Council (FFIEC) so as you can image its very comprehensive. Each domain has several associated components which are individually scored and rolled up into the chart you see below. Our goal for this year is to implement solutions to achieve 100% of the baseline risk category factors. These solutions will be comprised of hardware, software, policy, and procedures. As you can see by the chart we have made some good progress since February.



- **iv.** Cloud backup and Recovery All of our servers are now being backed up to the appliance on site and replicated to cloud storage at Iron Mountain in Colorado. This provides a level of redundancy that we have never had before and is the key component of our disaster recovery strategy.
- v. Network Traffic Logging Appliance We recently installed a new logging appliance that will take care of a few issues we had related to compliance and reporting. Every network device and server generates log files of things going on throughout the day. Millions of lines of logs are created every day which makes it impossible to gain any insight by reviewing them, there just simply isn't enough time in the day. That's where this appliance comes in. It captures and identifies everything generated by all of our

monitored devices and can alert us if there are any of types of events that we deem worthy of further inspection. In addition it also archives these logs which is a key component of our adopted security framework and the GLBA requirements.

b. Current Projects


- **i. Email Archiving Solution** We are currently around 75% done with implementation of this product. It provides compliance reporting, off site archive and hosting for disaster recovery, and alleviates the need for us to store all email on premise reducing the storage footprint for our email server.
- **ii.** Cloud Application Hosting We have moved 3 of our less utilized servers to the cloud and have been testing for a few months now. This is sort of a phase 1 to make sure that we have all the configuration items worked out before we begin to move a more heavily utilized server over. We anticipate that if things go as planned by this time next year we will have 2/3 of our servers being accessed from the cloud rather than on premise.
- **iii. Data Encryption** Sophos Safeguard has been installed and is currently being configured for deployment network wide. This product encrypts all files both at rest and in transit so that only authorized users can access sensitive information. This checks off a large box for us in terms of satisfying both GLBA data security rules as well as CIS Framework compliance.
- **iv.** Compliance Manager Currently using a new compliance manager product to manage governance, audits, and compliance. The initial use will be to manage our CIS Security Controls compliance. Once that is finalized we will use it for GLBA, GDPR, and other requirement to assure that we are utilizing the correct strategies and documenting them in the system. As you can imagine there is a ton of configuration that needs to be done on these frameworks to track them so considerable time will be spent getting everything in to the system and assigned. Below is the dashboard for the CIS Security Controls framework.




- **B.** Switchboard Mary continues provide premier customer service at the reception desk printing ID cards and answering the phones. She has been doing our monthly access reviews and disabling accounts that come up on the reports that no longer require access. This is been a huge help for us.
- C. Office Support Services Gloria and Mikah continue to provide exemplary service in the copy center. They remain busy providing not only mail service and stocking office supplies, but also providing the highly used central printing function for the institution. As you can see by the charts below, printing remains a heavily used part of office services and while the volumes are high, they remain vigilant to achieve any cost savings possible through the limited use of color copies and duplex printing whenever possible.



HLC UPDATE

I have some great news. NCCC is in year four of the Higher learning Commission's (HLC) Open Pathway to Accreditation. In year four we must write an "assurance argument," which is the new name of the "self study" of years past. The assurance argument is where we make the case that NCCC has met the Five Criteria (and 38 subcriteria) of accreditation. It was over 45,000 words long and cited over 500 pieces of evidence. We sent off that document on July 23rd to be read by the HLC peer review team assigned to our college.

Yesterday we received a letter from the HLC and the report from the team — we fully met all five criteria! Because we met all five without the need for follow-up we are already done! Our report does NOT have to go before the Institution Action Council (IAC) or the full HLC Board! NCCC will not have to respond to the HLC on these issues for another six years! Only about 20% of the approximately 1,000 institutions of higher education in the HLC has no follow-up or sanctions following a team visit. WOW! We did great!

The report is very glowing and complementary in places. In other places it has suggestions for improvement that we will be studying and responding to in our next assurance argument. I can say that I don't completely agree with everything the team wrote, but there are some good suggestions we can take advantage of.

Our next assurance argument is due in the 2023-2024 year and will come with a visit by a team of peer-reviewers on campus. Before that happens, however we must submit a "quality initiative" request sometime over the next three years, and follow that up with report on how that initiative went. At the next annual meeting in spring of 2019 we will be attending some training sessions on writing a successful quality initiative request and report.

I want to congratulate the Board as well as all employees for this wonderful achievement. Only with the entire college functioning well can we achieve re-accreditation without follow-up. This is powerful evidence of the wonderful faculty, staff, administration and trustees all working together for our students and our mission. Fantastic job! Special congratulations go to the HLC Committee and to Drs. Marie Gardner and Sarah Robb for their work to finish the document.

ASH GROVE FOUNDATION GRANT AWARD

NCCC has received a \$30,000 grant from the Ash Grove Foundation for the updating of our Oak Room. The first payment of \$15,000 has already been received with another \$15,000 coming after the first of the year. I wish to publically thank the Foundation for this very generous gift! The Oak Room is used by a variety of public organizations for their meetings as well as the main board room for NCCC. This money will help keep the room the show place that it should be.

KYLE'S ARTICLE!

Kyle Bures, the Coordinator of the Teaching and Learning Center at Ottawa, has been published in a national journal! NACADA, the national association for academic advising has a monthly publication called Academic Advising Today. I received a letter from their publisher that Kyle's article about our advisor certification system was selected for publication!

Advisor Training to the Core: A Case for a Web-Based Core Competency Training Model

Recently, all the necessary components for a perfect storm materialized to create a prime opportunity to design and implement an advisor certification program at Neosho County Community College. A shift of responsibilities within our advising organizational structure synchronized with a growing need for more formalized training, an influx of new advisors, and a **timely article** in the September 2017 issue of *Academic Advising Today* all culminated in the inspiration to develop and facilitate an in-house advisor certification for our college.

Many parallels exist between the approach taken by Wuebker and Cook (2017) and the Neosho model discussed here: including the goal of creating a "tool that not only helps prepare new advisors, but also enhances the knowledge and skills of experienced advisors, alleviates the responsibility of advising units to create their own trainings, provides consistency across independent advising offices, and enables advising administrators easy access to resources for staff development" (para. 13). In addition, the Neosho model was similarly housed within our institutional learning management system and focused on the NACADA Academic Advising Core Competencies (NACADA, 2017) as a guiding framework.

NCCC ranked #2 in the state in terms of average salary for tech majors out of 26 two-year institutions!! Only one community college beat us and it was only by \$168 per year to be #1, but we had four times the number of graduates that community college had.

When you factor in <u>all</u> associate degree students, including the AA and AS students, we fall to #6 in the state in average salary, but we are #5 in number of graduates! We are about 13th in terms of size but 5th in graduates! Not bad at all!

Here is the chart of ALL degree and certificate students. Notice the average salary falls from nearly \$40,000 for tech only in the previous chart for NCCC, to \$32,300 for all graduates. Tech graduates make more, at least in the first year out of college.
